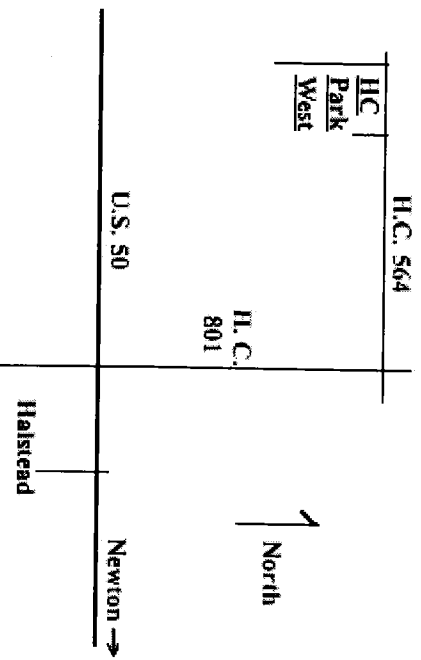

Go north 4 miles to H.C. 564  
Turn west 3.5 miles to the Park
